**2009-281** An Ordinance Annexing Certain Described Property On Hazel Lane Located In North Hazel Dell Subdivision. **(Requested By Ald. Griffin) (Public Works)**

Annexes certain described property on Hazel Lane located in North Hazel Dell Subdivision to the City of Springfield.

**2009-282** An Ordinance Annexing Certain Described Real Property Located At 465 West Lake Shore Drive (Majerus And Fliss). **(Requested By Ald. Griffin) (Public Works)**

Annexes property located at 465 West Lake Shore Drive to the City of Springfield.

**2009-283** An Ordinance Authorizing Additional Payment Of \$53,488.50 To Sangamo Construction Company Under Contract PW 09-05-35 For A Total Amount Not To Exceed \$543,488.50 For The 2008 Residential Sidewalk Program For The Office Of Public Works. **(Requested By Ald. Griffin) (Public Works)**

Additional lineal feet were constructed than originally anticipated therefore additional payment is needed. A change order is not necessary because the components were bid out using unit prices which still remain in effect.

**2009-284** An Ordinance Renaming That Portion Of Road Now Known As Cotter Drive To Teamster Way For The Office Of Public Works. **(Requested By Ald. Griffin) (Public Works)**

Renames Cotter Drive to Teamster Way for the Office of Public Works. The road is located west of I-55, east of Granger Drive and south of Bissell Road.

**2009-285** An Ordinance Approving The Final Plat For The Redivision Of Lot 2B-4A In White Oaks West – First Addition For The Office Of Public Works. **(Requested By Ald. Griffin) (Public Works)**

Approves the final plat of the redivision of Lot 2B-4A of the redivision of Lot 2B-4 of the redivision of Lot 2B of the redivision of Lot 2 in White Oaks West, First Addition for the Office of Public Works. The subdivision is located west of Veteran's Parkway, north of Wabash Avenue and south of Iles Avenue.

**2009-286** An Ordinance Authorizing Execution Of An Agreement For The Purchase Of A Tandem Axle Truck With High Pressure Vactor And Sewer Cleaning Equipment From Prairie/Archway International Trucks, Inc. At A Net Cost After Trade-In Of A 2000 Vactor Unit Of \$261,789.00 For The Office Of Public Works. **(Requested By Ald. Griffin) (Public Works)**

This new unit's cost is \$317,714.00. We are trading in a 2000 Vactor unit for a credit of \$56,000.00 resulting in a net cost of \$261,789.00. This is in our Five Year Plan and on schedule to be replaced.

**2009-287** An Ordinance Repealing Ordinance 239-04-09 Amending Chapter 170, Section 170.10.25(B)(2) Of The 1988 City Of Springfield Code Of Ordinances, As Amended, To Revise The Residential Fee Schedule For Building Permits; Reinstating The Previous Schedule; And Authorizing Reimbursement Of Funds Paid Under That Fee Structure. **(Requested By Ald. Griffin) (Public Works)**

Per the request of Alderman Frank Edwards and Alderman Frank Kunz, this ordinance will repeal ordinance number 239-04-09, reinstate the previous residential fee schedule for building permits and authorize reimbursement of funds paid to permit applicants if requested within 60 days after passage of this ordinance.

**2009-288** An Ordinance Approving A Four-Way Stop Intersection At Bel Aire Drive And Glen Aire Drive. **(Requested By Ald. Griffin) (Public Works)**

Residents in the area of Bel Aire Drive and Glen Aire Drive have expressed concern about the speed of traffic at this intersection, therefore, Alderman Kunz is requesting that stop signs be placed in this area to create a four-way stop intersection.
