AN ORDINANCE APPROVING AND AUTHORIZING EXECUTION OF AN AGREEMENT WITH MICHAEL A. WILLIAMS, AN OFFICE OF PUBLIC UTILITIES EMPLOYEE, FOR SETTLEMENT AND RELEASE OF ALL CLAIMS AGAINST THE CITY OF SPRINGFIELD AND AUTHORIZING A SUPPLEMENTAL APPROPRIATION FOR THE OFFICE OF PUBLIC UTILITIES, FOR EMERGENCY PASSAGE.		

**AN ORDINANCE APPROVING AND AUTHORIZING EXECUTION OF AN AGREEMENT WITH MICHAEL A. WILLIAMS, AN OFFICE OF PUBLIC UTILITIES EMPLOYEE, FOR SETTLEMENT AND RELEASE OF ALL CLAIMS AGAINST THE CITY OF SPRINGFIELD AND AUTHORIZING A SUPPLEMENTAL APPROPRIATION FOR THE OFFICE OF PUBLIC UTILITIES, FOR EMERGENCY PASSAGE**

**WHEREAS**, Michael A. Williams, an Office of Public Utilities employee, has filed a discrimination claim against the City, and

**WHEREAS**, Mr. Williams and the City (the "Parties") desire to settle in full any and all claims that either Party may have or could have asserted in the claim or any other claims arising out of Mr. Williams' employment with the City; and

**WHEREAS**, Mr. Williams is willing to accept \$225,000.00 to settle and release all claims against the City; and

**WHEREAS**, it is necessary to execute an agreement setting forth the terms of the settlement; and

**WHEREAS**, a copy of the settlement agreement shall be on file in the Office of the City Clerk; and

**WHEREAS**, the Office of Public Utilities is requesting a supplemental appropriation in the amount of \$225,000.00 to cover the cost of this settlement.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SPRINGFIELD, ILLINOIS:**

**Section 1:** That the City Council hereby authorizes payment of \$225,000.00 to, and execution of an agreement with, Michael A. Williams, an Office of Public Utilities employee, for settlement of any and all claims arising out of Mr. Williams' employment with the City. The Mayor and City Clerk are authorized to execute any necessary documents on behalf of the City.

**Section 2:** That the City Council hereby authorizes a supplemental appropriation in the amount of \$225,000.00 for the Office of Public Utilities.

**Section 3:** That the Office of Budget and Management is hereby authorized to effectuate this supplemental appropriation into expenditure account 101-100-H-6287-2205 as follows:

**Section 4:** That the Office of Budget and Management is hereby authorized to make payment in an amount not to exceed \$225,000.00 to Michael A. Williams and his attorney at Rhode & Jackson, P.C., from account number 101-100-H-6287-2205 in accordance with the terms of the settlement agreement.

**Section 5:** That the City Clerk is hereby directed to publish this ordinance in pamphlet form.

**Section 6:** That this ordinance shall become effective immediately after its passage, recording and publication in pamphlet form.
