**AN ORDINANCE GRANTING THE PROPERTY LOCATED AT 400 EAST SOUTH GRAND AVENUE AND 1325 SOUTH 5<sup>TH</sup> STREET RECLASSIFICATION TO B-1 HIGHWAY BUSINESS SERVICE DISTRICT, SECTION 155.033 OF THE SPRINGFIELD ZONING ORDINANCE.**

**WHEREAS**, the City of Springfield is a home rule unit as defined in Article VII, Section 6(a) of the 1970 Illinois Constitution and has jurisdiction over matters pertaining to its government and affairs; and

**WHEREAS**, on January 20, 2010, the Springfield Planning and Zoning Commission heard a Petition for Reclassification to B-1, Highway Business Service District, for the property located at 400 East South Grand Avenue and 1325 South 5<sup>th</sup> Street, Springfield, Illinois, legally described as follows:

**Parcel 1: The North twenty feet (20') of Lot Five (5) and all of Lots Six (6), and Seven (7) and Eight (8) in Block One (1) of George Carpenter's Subdivision of part of the East Half (E 1/2) of the Northeast Quarter (NE ¼) of Section Four (4), Township Fifteen (15) North, Range Five (5) West of the Third Principle Meridian; commonly known as 400 South Grand Avenue East, Springfield, Illinois. (Index No. 22-04-0-228-012)**

**Parcel 2: George Carpenter's Sub. PT E ½ of NE L3 B1 in 4-15-5 and George Carpenter's Sub. PT E ½ of NE L4 B1 4-15-5, City of Springfield, Sangamon County, Illinois.**

**WHEREAS**, all statutory notice requirements have been fulfilled in regard to said hearing; and

**WHEREAS**, the Springfield Planning and Zoning recommended that the Springfield City Council approve the petition as amended; and

**WHEREAS**, the Springfield City Council agrees in part with the recommendation of the Springfield Planning and Zoning Commission, and finds adequate factual basis for said recommendation adopting the Commission's findings and its own findings.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SPRINGFIELD, ILLINOIS:**

**Section 1:** That the property located at 400 East South Grand Avenue and 1325 South 5<sup>th</sup> Street, as legally described above, is hereby granted Reclassification to B-1, Highway Business Service District, Section 155.033, except that the property may not be used for the following uses: (1) automotive, truck or boat sales or rentals; (2) any trailer camps or mobile home camps or travel trailer parks; (3) amusement parks; (4) warehouses; (5) kennels.

**Section 2:** All ordinances, resolutions and parts thereof in conflict herewith be and the same are hereby repealed.

**Section 3:** The Zoning Administrator is hereby directed to amend the map according to the provisions stated herein.

**Section 4:** This Ordinance shall become effective immediately upon its passage and recording by the City Clerk.
