Re: Background / Financial Stability Investigation Questionnaire

Enclosed you will find the required application for the "Background/ Financial Stability Investigation Questionnaire." This must be filed along with a non-refundable fee of \$70.00. Checks / Money orders should be made payable to the City of Springfield and returned to Municipal Center East, 800 East Monroe Room 108, Springfield, Illinois 62701 along with the completed background application.

This application must be completed in full (every line item) and your signature notarized. Page 7 is the "Authorization for the Release of Personal Information" and it needs to be completely filled out and witnessed.

The person(s) required to have a background check done are as follows: the individual(s) who's name will appear as the license holder; all partners, (including limited and general) in the case of a partnership or limited partnership; all officers, directors, and stockholders of more than 5% in the case of corporation.

Licensees must be legal residents of the City of Springfield, except in the case of limited partnerships and corporate licenses. In this event, the business must have a manager who is a legal resident of the City of Springfield, who must submit to a background check.

Please be aware that a background check is normally a rather lengthy process; so submit this questionnaire with this in mind.

*Fingerprints are required as part of the check; an appointment will be set up with the Business Licensing Department in Room 108 of the Municipal Building East located at 800 East Monroe Street, Springfield, Illinois, to review your application collect all fee's and give the applicant further direction if needed on getting electronic finger prints done. If you reside outside of the Springfield area, you may mail your background application to the above address. Please include a copy of your State I.D. or State Drivers license for identification purposes. We will need the completed background application and fee before we can perform the check.

Lastly, you have a right to challenge the results of your background investigation with the Illinois State Police. For more information, please refer to the informational document titled "Right of Access and Review Procedure" attached hereto.

RIGHT OF ACCESS AND REVIEW PROCEDURE

Pursuant to Illinois Administrative Rule Title 20 Chapter II Part 1210, effective July 1, 2015, an individual may retain a copy of their Illinois criminal history record obtained through the right of Access and Review process. The individual must submit a set of fingerprints to the Illinois State Police (ISP), Bureau of Identification (BOI) in the form and manner prescribed by the ISP. An individual may submit the request through a local law enforcement agency, correctional facility (if incarcerated), or an Illinois licensed live scan fingerprint vendor. The Illinois State Police does not charge a fee for this service. However, the entity providing the fingerprint service may charge a processing fee.

The ISP will return a copy of the Illinois criminal history transcript record along with a Record Challenge form to the address provided with the Access and Review submission. The ISP will send the response to the local law enforcement agency or correctional facility for pick up by the individual if no requester address is included in the submission.

Individuals may challenge their record and request corrections by completing and submitting the Record Challenge form. The ISP will respond in writing to the record challenge. Additional information or instructions on challenging Illinois criminal history record information is located on the ISP web site at http://www.isp.state.il.us/crimhistory/viewingchrireds.cfm.

The ISP, BOI does not maintain arrest case reports or statements taken by other arresting agencies. Requests for this type of information should be directed to the investigating police department or the circuit clerk of the county where the case was heard.
