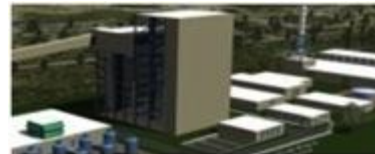

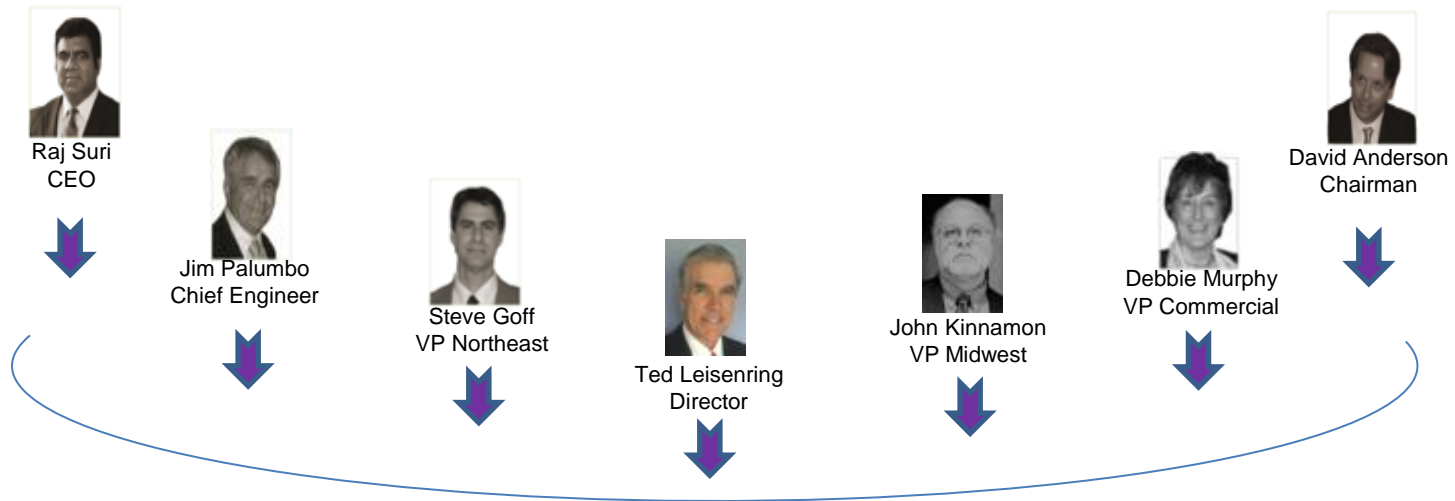

EmberClear – a Successful Power Developer



- The 360 MW **Good Spring Power Project** is located in the Schuylkill County, PA.
- In 2014, the Project was substantially completed and sold to Tyr Energy (owned by the \$20Billion ITOCHU Corporation of Japan)
- Project Budget \$400 million
- Construction likely to start in Q2-2018
- EmberClear continue to provide development services until the construction begins



- 490 MW **Birdsboro Power Project** located in Berks County, PA.
- In 2017, the Project was sold to Ares (\$95 Billions Fund), Tokoyo Gas and Sojit Japan.
- Project Budget \$600 million.
- The construction started in Feb 2017. Operations to start on May 2019.
- EmberClear has been retained until the operations start



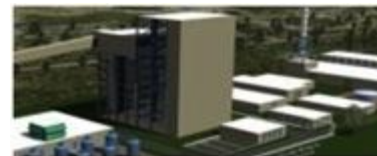
- **Archbald Power Project** (2 x 490MW Units) is located in Lackawanna County, PA
- 50:50 Partner with DCO Energy
- Air Permit on first unit received in June 2017
- Project is likely to start construction in 2019



- 1100 MW **Harrison Power Project** located in Harrison County, OH
- Partnered with CB&I to co-develop & subsequently construct the Project
- Permitting started in mid-2016
- Equity to be secured in Q1-2018
- Project is on track to begin construction in Q3 2018.

UNDISCLOSED

- 1100 MW **Lincoln Land Energy Center** located in Sangamon Co, IL
- Preliminary feasibility has been completed
- Enterprise Zone – targeted for August 2017
- Project is targeted to start construction in 2019

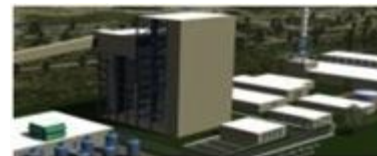

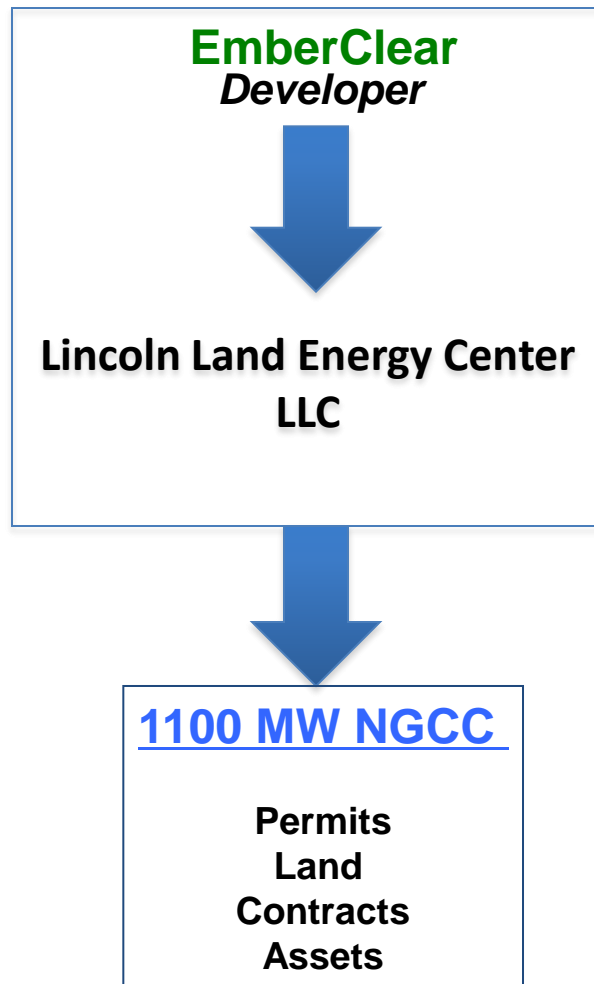

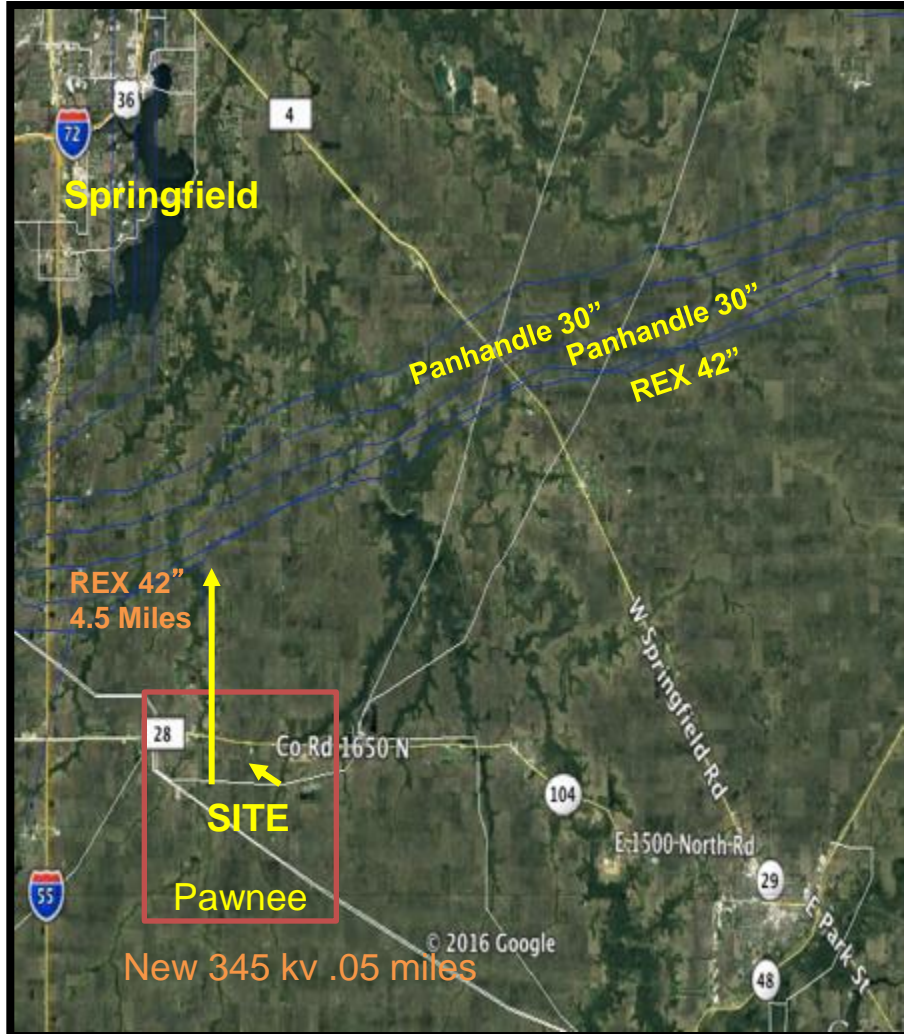
- 80-Acre Site in Pawnee (Sangamon)

Lincoln Land Power Project Overview (cont..)



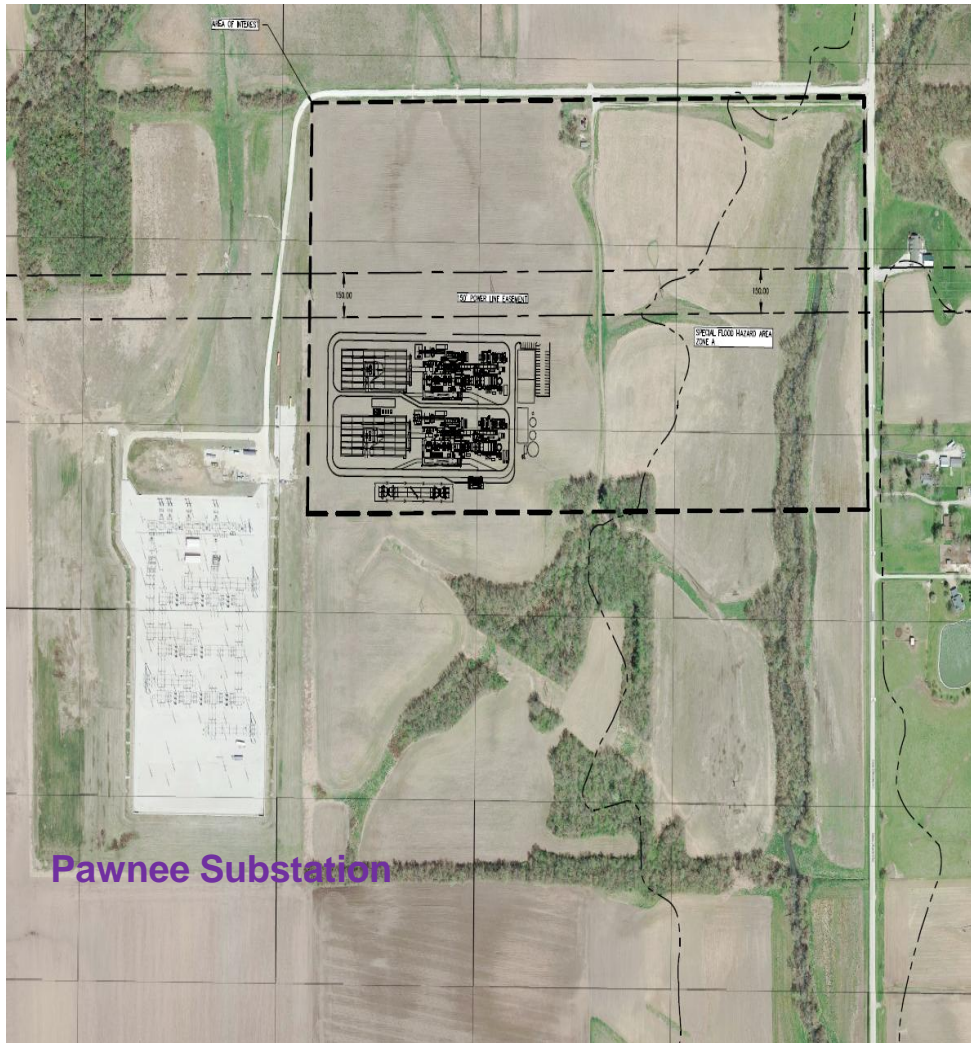
- Site – Pawnee, Illinois, (12 miles to Springfield)
- Site controlled by EmberClear
- A 80-acre greenfield flat parcel
- New major Sub-Station adjacent to the site
- Water from City Water Light and Power back up by Pawnee
- Water discharge City of Pawnee
- REX and PEPL pipelines within 4.5 miles
- State road and heavy rail access
- Site Option Agreement – Feb 2017

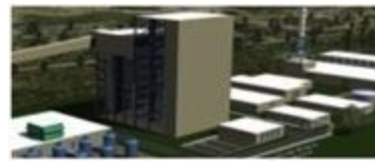
Lincoln Land Power Project Overview



- Site – minimal connectivity issues
- Pending approval of Enterprise Zone Site - sales tax exemption, property tax abatement, etc.
- Pending joint development agreement with City, County and State
- Transmission Capacity identified through screening studies
- New major Ameren Sub-Station adjacent to the site

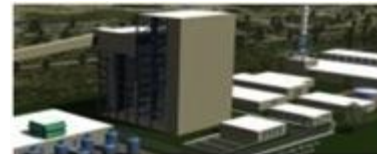

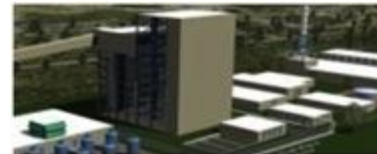

Current Timeline Target Dates:

- Sept 30, 2017** Enterprise Zone Agreement
- Nov 30, 2017** Begin preparation of Air Permit & NPDES Permit
- Jan 30, 2018** Submit Air Permit & NPDES Permit
- Feb 28, 2018** MISO market assessment
- Oct 15, 2018** Assess MISO Queue results to determine project next steps
- Jan 15, 2019** Receive Air Permit & MISO Queue Definitive Agreement
- July 15, 2019** Finalize commercial contracts (EPC, Water, Gas Supply)
- Sep 15, 2019** Financial Close, Notice to Proceed to Construction
- Nov 30, 2022** Operations Start
