Alderman Senor made a motion accept the staff recommendation of the variance with denial of the requested zoning, but grant use variance to allow storage warehouse to allow storage of scenery and props with accepting the pavement extensions sections 155.112, 155.111, and 155.136 to 24 months with recommendation from the traffic engineer. Alderman Thelien seconded the motion.

Alderman Senor wanted to make it clear that this would not affect the Lincoln Colored Home. Matt McLaughlin with Building and Zoning said that Sangamon County had two parcels with the same address. The vacant parcel will go away and the Lincoln Colored Home will keep its address and that the vacant lot will use the same address as the Lincoln Colored Home.

Angela Harris, 1202 East Capitol, said that they are in support of this zoning issue and encourage a yes vote.

PETITIONER(S): City of Springfield

Consideration of the 2037 Comprehensive plan for the City of Springfield, Illinois as amended

A public hearing was held November 16, 2017 in front of the Planning and Zoning Commission. At that time the Plan was presented and an amendment proposed and accepted by the Planning and Zoning Commission. Testimony was heard be opponents and proponents of the plan. The Commission was also provided with written comments that had been submitted to the City on the Plan. After the presentation, comments and discussion the Commission made its recommendation.

<u>PLANNING AND ZONING COMMISSION RECOMMENDATION IS</u>: Accept the Comprehensive Plan as amended.

Alderman Hanauer made a motion to continue the docket item to the January 16, 2018 zoning meeting. Alderman Redpath seconded the motion. Alderman Hanauer would still like to have some discussion on it tonight since there are people hear that have signed up to talk about it.

Alderman McMenamin wanted to know the reason for the continuance. Alderman Hanauer said that there was some concern from realtors and developers. This plan is for twenty years, and he wants to make sure that the plan will work for everyone. Alderman McMenamin said that at the

Building and Zoning meeting when this was approved; it was approved unanimously. There were surveys done as well as members attending the ward meetings to hear what citizens wanted. It should be pointed out that there should have been better participation along the way. Alderman Senor said that this is an important document and should allow people to be heard before the final vote. Alderman Theilen echoed Alderman Senor statement and said that the Council should allow the people that will work closest to the Comprehensive Plan to have a voice before the final vote.

Alderman Proctor agreed that there are some minor tweaks that need to take place and the plan will be acceptable to all the parties. Alderman DiCenso said that she wants to know what amendments are to be offered, but she did not get that information, but other Alderman did and she has a problem with that. Alderman McMenamin said that the Council is double faced and that relies on staff information, but now want to add amendments without any information or background.

Alderman Donelan wanted to say that this is a great plan that incorporates history while making way for the future. This is a guide and a plan for the future. Alderman Turner said that this is important documents that will guide the city for the next thirty years, and we should take as much time to get it right. It also needs to be a user friendly document.

Next, Dean Graven of 3411 Mackinaw Lane, is a member on the Springfield Area Homebuilders, Chairman of the Development Policy Council, and a voting member on the Regional Planning Commission. He would like to thank the Council for continuing this for another month because talking with bankers, developers, builders and engineers there just needs to be a little bit more time. There needs to be a good Comprehensive Plan, because if no one invests in Springfield it will die because of lack of growth.

Next, Jim Clayton with the Illinois Realtors wanted to thank the steering committee for all the hard work they did completing the Comprehensive Plan. The realtors like the plan, but they want a delay so there could be some clarification on a few things. There hasn't been enough time to go through the plan and get the clarification on the some of the language in the plan.

Next, Chris Hembrough, President and CEO of the Springfield Chamber of Commerce said that they would like a delay in approving the plan so that there can be an amendment to clarify some points of concern.

Next, Carol Kneedler of 2016 South Fourth Street spoke about the Bloomington Comprehensive Plan and how the developers had input in to the plan and had their questions answered during the process. She wished Springfield developers would have been more involved with the process here in Springfield.

Next, Norm Sims executive director of the Springfield-Sangamon County Regional Planning Commission said that this plan does not change the zoning map. If a property is currently zoned commercial, it will continue to be zoned commercial with the passage of the plan. In running these plans through simulations, there is a projected 15% growth with the recommendations that

were made. Mr. Sims said a delay would be beneficial so that we can get rid of some misunderstandings and misinformation with the zoning issues.

The motion to postpone the vote until January 16, 2018 was passed on a vote of 9-0-1 with Alderman McMenamin voting present.

Next, Alderman Theilen asked for a moment of silence for Judge John Schmidt who passed away earlier today.


Next, Mayor Langfelder asked Treasurer Buscher for the Treasurer's Report. The Corporate Fund had beginning balance for the month of November 2017 \$6,846,589. The City took in \$7,327,685 and total disbursements of \$7,057,942 with an ending balance for November 2017 of \$7,116,332. Alderman Hanauer made a motion to approve the Treasurer's report. Alderman Turner and Theilen seconded the motion. The motion passed on a voice vote of 10-0.

Next, Mayor Langfelder asked for a motion to dispense with a reading of the minutes of the December 5, 2017 City Council meeting and approve the minutes. Alderman McMenamin made the motion with Alderman DiCenso seconding the motion. The motion passed on a voice vote of 10-0.

Next, Mayor Langfelder asked for a motion to incorporate the Pre Council first reading of ordinances into the record of the Council meeting. Alderman Donelan made the motion with Alderman DiCenso and Theilen seconding. The motion passed on a voice vote of 10-0.

Next, Mayor Langfelder asked for motion to incorporate the pre-council reading of the consent agenda into the record of the city council meeting. Alderman Hanauer made the motion with Alderman DiCenso seconding the motion. The motion passed on a voice vote of 10-0.

Next, Mayor Langfelder asked for a motion to put the consent agenda on final passage. Alderman Donelan made the motion for final passage. Alderman DiCenso seconded the motion.



Next, agenda item 2017-562 an ordinance accepting grant #414514 FD02 under FY14 Edward Byrne Memorial Justice Assistance Grant program for a partnership with Southern Illinois University entitled reduce violence (focus deterrence) in the amount of \$196,615.00 authorizing a supplemental appropriation of \$50,054.00 of said grant funds for FY 18 for the Springfield Police Department for emergency passage. Alderman Theilen made the motion to place the agenda item on final emergency passage. Alderman Hanauer seconded the motion. Alderman Senor wanted to know what program they will use the grant money on. Chief Winslow said that

this is a grant to fund a program to reduce gun violence and youth offenders. The department will be hiring four officers to be a part of this program.

The motion passed on a vote of 11-0 voting yes: Alderman Redpath, Alderman Senor, Alderman Turner, Alderman Fulgenzi, Alderman Proctor, Alderman DiCenso, Alderman McMenamin, Alderman Theilen, Alderman Donelan, Alderman Hanauer, and Mayor Langfelder

Next, agenda item 2017-563 an ordinance authorizing the execution of an agreement with the Board of Trustees of Southern Illinois University to provide a grant research partner required by a grant from the Illinois Criminal Justice Information Authority for the focused deterrence grant #414514 for an amount not to exceed \$61,302.00 beginning December 13, 2017, through December 12, 2018 for the Springfield Police Department for emergency passage. Alderman Senor made a motion to place the agenda item on final emergency passage. Alderman Senor wanted to know if this is part of the grant that was just passed. Deputy Chief Dyle Stokes said that this is part of that grant and will pay for one individual. The motion passed on a vote of 11-0 voting yes: Alderman Redpath, Alderman Senor, Alderman Turner, Alderman Fulgenzi, Alderman Proctor, Alderman DiCenso, Alderman McMenamin, Alderman Theilen, Alderman Donelan, Alderman Hanauer, and Mayor Langfelder,

Next, Alderman McMenamin asked that the Inspector General reports get to the Aldermen before the meeting so that Aldermen could have some time to come up with questions to ask the Inspector General.

Next, Alderman Turner said that she has spoken with the owner of the Wet Bar and what has gone on in the past. She hopes that any complaints against a bar owner is held in the same fair manner. Alderman Proctor said that there needs to be better monitoring of the bars when complaints come in.

Yatti Ely, 2301 West Iles and owner of the Wet Bar, addressed the Council about some of the issues that have come up at his bar. He said that his bar has taken a hit with the loss of his 3 AM license. He understands that he needs to correct the issues that face his bar so that he can get the 3 AM license.

Next, Alice Ramey spoke against any bar having a 3AM license. Downtown is an important part of Springfield and needs to be taken care of.

Next, Mayor Langfelder asked for a motion to recess the regular session of the City Council meeting and to go into Executive Session for pending and probable litigation pursuant it to 5ALCS1202CL of the Illinois Open Meetings Act. Alderman Donelan made the motion. Alderman Theilen seconded the motion. The motion passed on a voice vote of 10-0.

The City Council recessed at 7:25 P.M.

Mayor Langfelder asked for a motion to reconvene the regular session of City Council. Alderman Hanauer made the motion, with Alderman DiCenso seconding the motion. The motion passed on a voice vote of 10-0. The meeting resumed at 7:34 P.M.

Next, Mayor Langfelder wanted to remind everyone that that there is no meeting next Tuesday, December 26, 2017 because the city will be closed and that the Committee of the Whole meeting will take place on Wednesday, December 27, 2017.

Next, Mayor Langfelder asked for a motion to adjourn the council meeting. The motion was made by Alderman Senor and seconded by Alderman DiCenso and Hanauer. The motion passed on a voice vote of 10-0. The December 19, 2017 City Council Meeting adjourned at 7:35 P.M.
