

AN ORDINANCE AUTHORIZING EXECUTION OF A REQUEST FOR APPROVAL OF A CHANGE IN PLANS WITH, AND ADDITIONAL PAYMENT OF ~~\$2,661.93~~\$26,661.93, FOR A TOTAL NOT TO EXCEED \$206,612.93 TO, EGIZII ELECTRIC INC. FOR TRAFFIC SIGNAL INSTALLATION AT COOK STREET AND EASTDALE AVENUE, MFT SECTION 08-00458-00-TL, FOR THE OFFICE OF PUBLIC WORKS, AS AMENDED

**Proposed Amendment No. 1 for
2012-077**

WHEREAS, the City of Springfield is a home rule unit as defined in Article VII, Section 6(a) of the 1970 Illinois Constitution and has jurisdiction over matters pertaining to its government and affairs; and

WHEREAS, the City Council previously passed ordinance 428-11-10 authorizing Contract Index No. PW 11-09-57 with Egizii Electric, Inc. to furnish construction of traffic signals at Cook Street and Eastdale Avenue in an amount not to exceed \$179,950.60, MFT Section 08-00458-00-TL, for the Office of Public Works (the Project); and

WHEREAS, additional sidewalk needed to be removed and replaced, conduit needed to be installed and rock excavated due to existing soil conditions and utility locations; and

WHEREAS, due to these circumstances it is necessary to execute a Request for Approval of Change in Plans with the Illinois Department of Transportation for the Project and authorize additional payment ~~\$2,661.93~~ \$26,661.93 for a total amount not to exceed \$206,612.93 to Egizii Electric, Inc. for traffic signal installation at Cook Street and Eastdale Avenue; and

WHEREAS, a copy of the Request for Approval of Change in Plans to contract PW 11-09-57 shall be on file in the Office of the City Clerk; and

WHEREAS, the circumstances said to necessitate the changes were not reasonably foreseeable at the time the contract was signed.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SPRINGFIELD, ILLINOIS:

Section 1: That the City Council hereby authorizes execution of a Request for Approval of Change in Plans for Contract Index No. PW 11-09-57 and additional payment of ~~\$2,661.93~~ \$26,661.93 for a total amount not to exceed \$206,612.93 to Egizii Electric Inc. for traffic signal installation at Cook Street and Eastdale Avenue, MFT Section 08-00458-00-TL. The Mayor and City Clerk are authorized to execute any necessary documents on behalf of the City of Springfield.

Section 2: That the Office of Budget and Management is hereby authorized to pay Egizii Electric Inc. (OEGI4900) ~~\$2,661.93~~ \$26,661.93 for a total amount not to exceed \$206,612.93 from account 041-110-GAST-STRS-2307 upon satisfactory performance of Contract No. PW 11-09-57.

Section 3: That this ordinance shall become effectively immediately after its passage and recording by the City Clerk.
